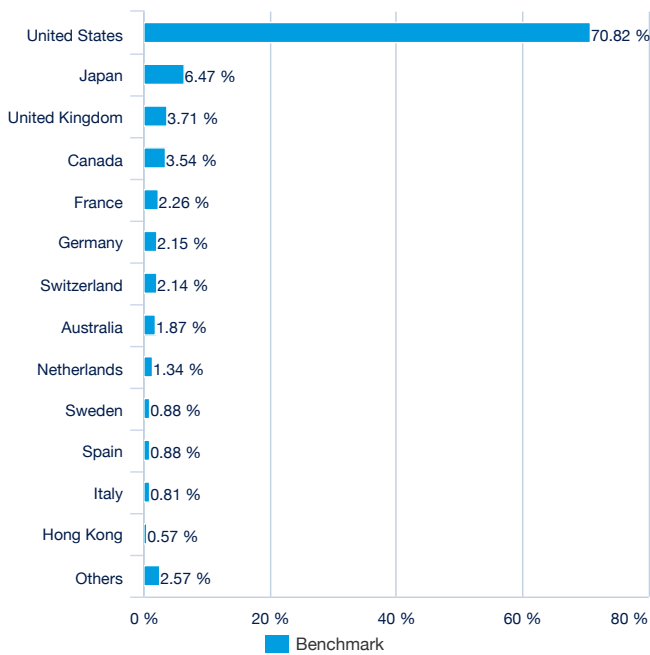
Description of the Index

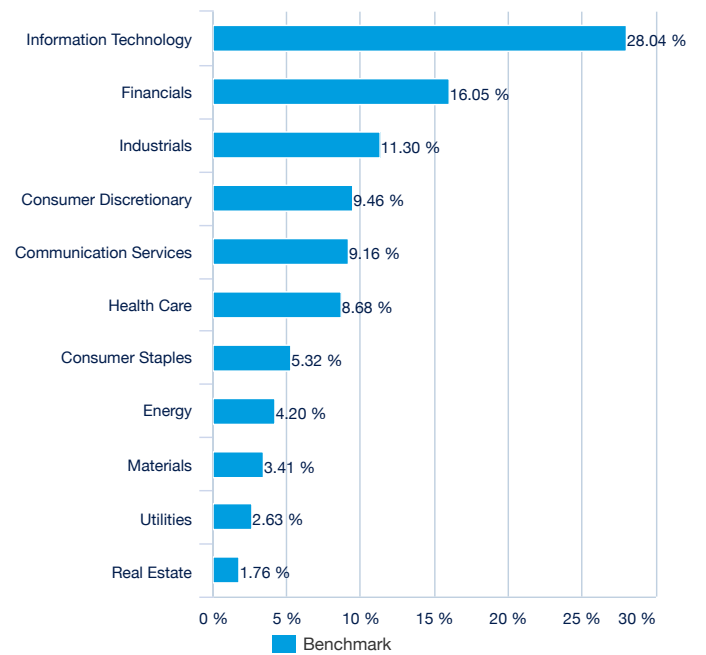
