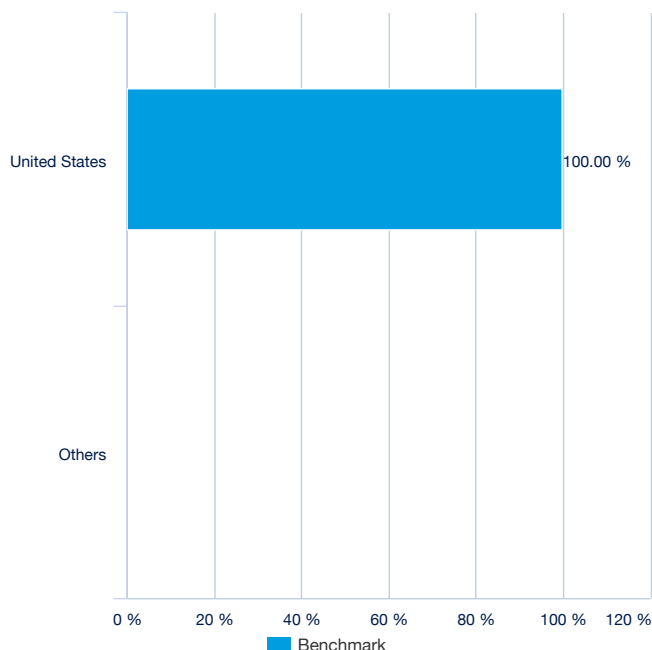
Description of the Index

The objective of this Sub-Fund is to track the performance of the MSCI USA Index (the "Index"). The Index is a Net Total Return Index: dividends net of tax paid by the index constituents are included in the Index return. 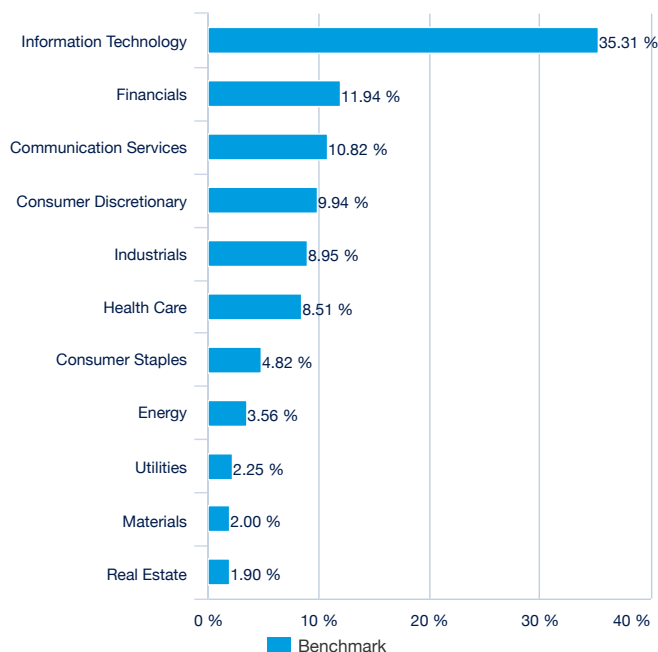
