Objective and Investment Policy

The Amundi US Treasury Bond 1-3Y UCITS ETF GBP Hedged Dist is a UCITS compliant exchange traded fund that aims to track the Bloomberg Barclays U.S. Treasury: 1-3 Year Total Return Index. The GBP-hedged share class offers the simplicity of a monthly currency hedge mechanism that is embedded in the investment product, representing an efficient solution to manage the foreign-exchange risk.

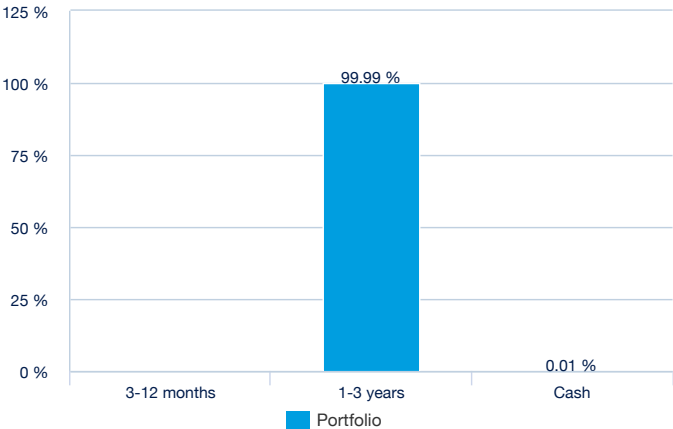

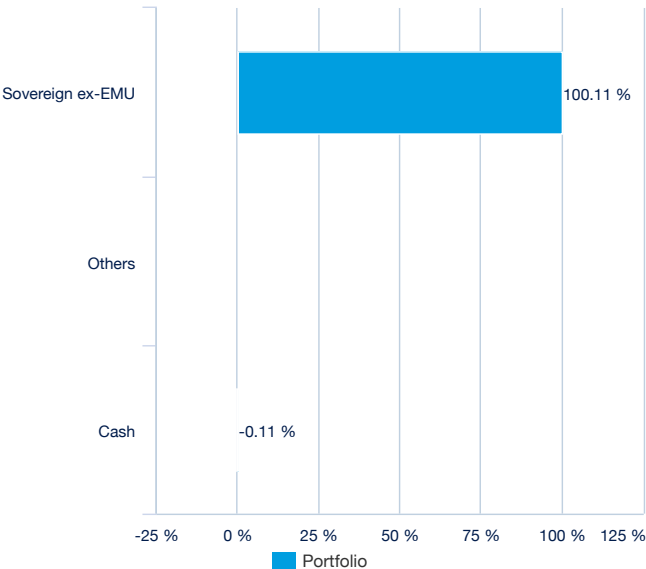
By maturity (Source: Amundi)



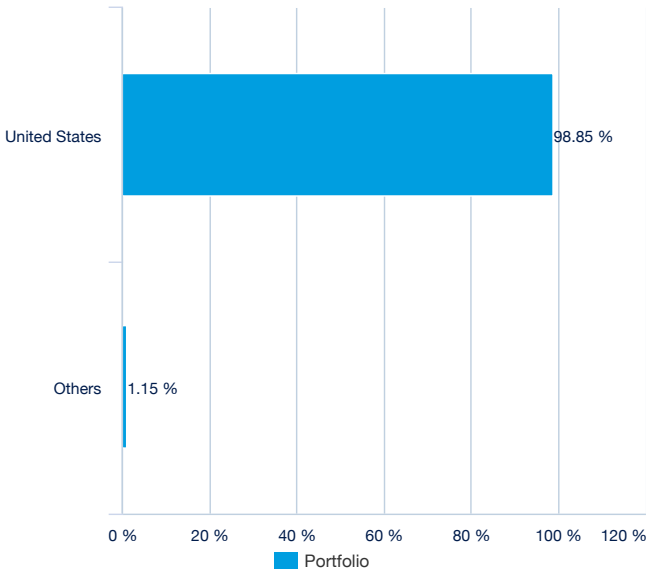
