Objective and Investment Policy

The investment objective of Amundi Global Green Bond 1-10Y (DR) UCITS ETF is to track both the upward and the downward evolution of the "Bloomberg MSCI Global Green Bond 1-10 Year Index" (the "Index") denominated in Euros, in order to offer an exposure to the Green Bonds market issued by investment grade entities and denominated in multiple currencies – while minimising the volatility of the difference between the return of the Sub-Fund and the return of the Index (the "Tracking Error"). For monthly hedged share classes mentioned in APPENDIX C - SUMMARY OF SHARES AND FEES, the Sub-Fund will also use a monthly currency-hedge strategy, in order to minimize the impact of the evolution of each respective share class currency against currencies of each Index component. The anticipated level of the Tracking Error under normal market conditions is expected to be up to 0.50%.

Amundi ETFs are efficient investment vehicles listed on exchange that offer transparent, liquid and low-cost exposure to the underlying benchmarkindex.

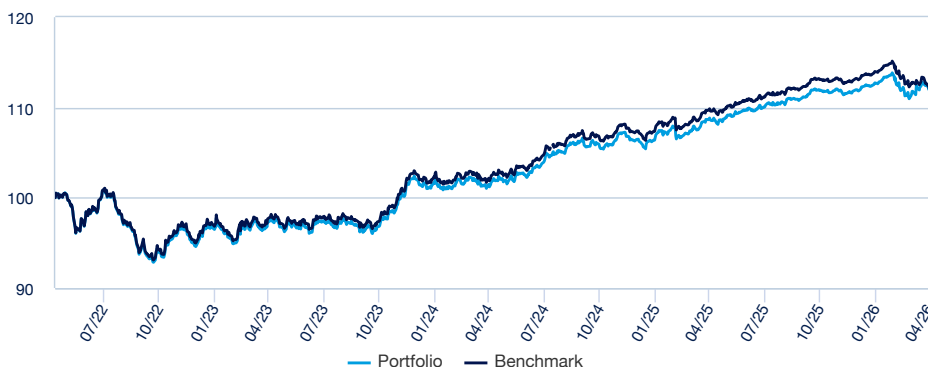

Description of the Index

The Benchmark Index is representative of the performance of Green Bonds issued by investment grade entities and denominated in multiple currencies. Green Bonds are issued in order to fund projects that have positive environmental outcomes. To be eligible in the Benchmark Index, Green Bonds are independently evaluated by MSCI ESG Research along four dimensions to determine whether they should be classified as green bond: stated use of proceeds, process for green project evaluation and selection, process for management of proceeds, commitment to ongoing reporting of the environmental performance of the use of proceeds. 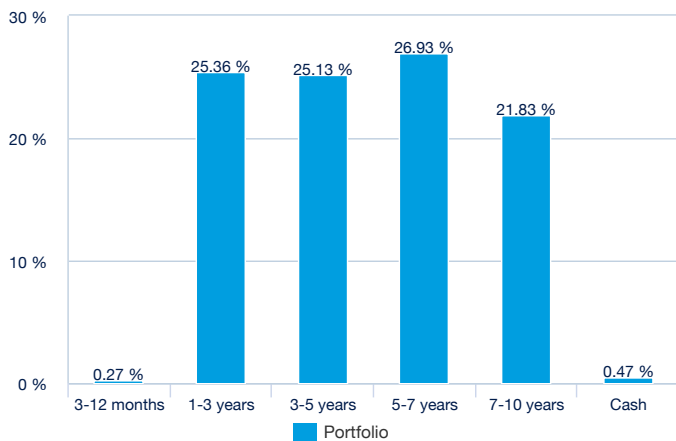

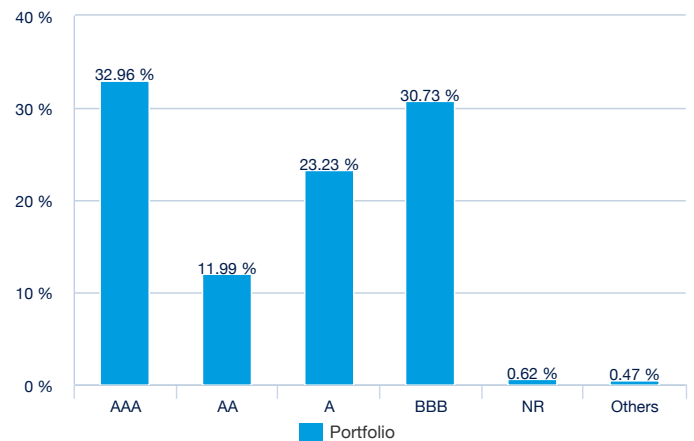

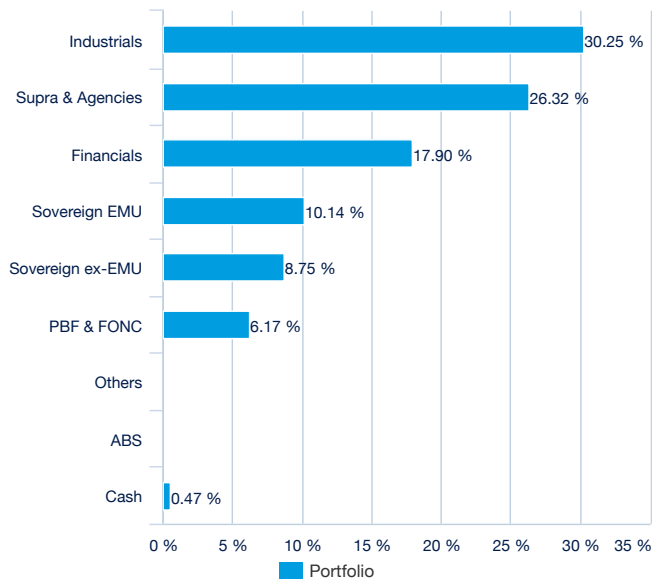
By maturity (Source: Amundi)



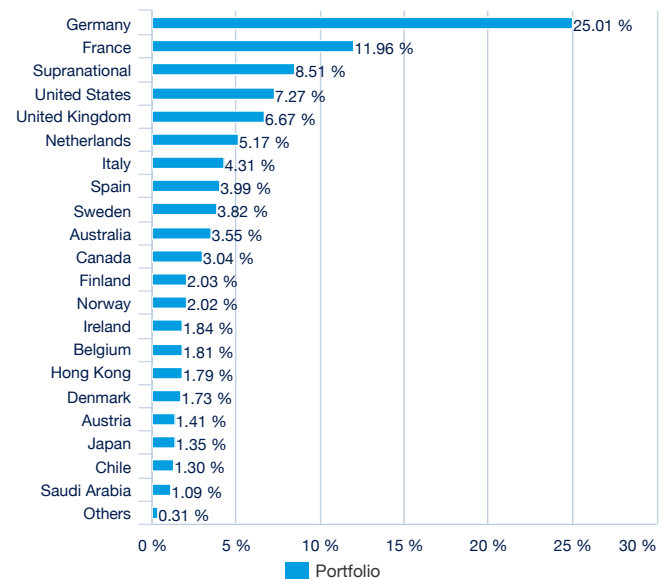
