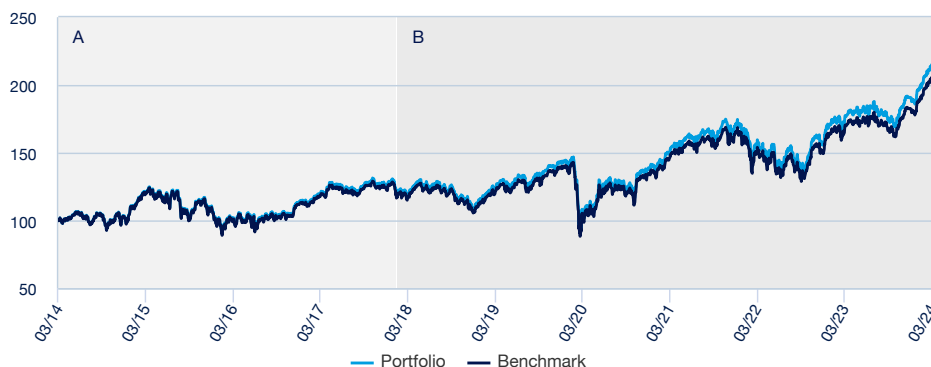

EURO STOXX® 50 Index is an equity index representative of the 50 leading securities of Eurozone developed countries (as defined in the index methodology).

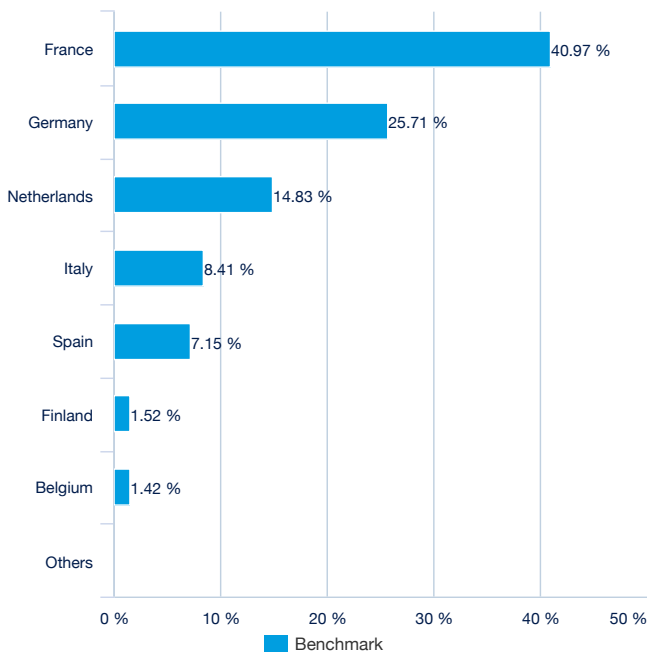

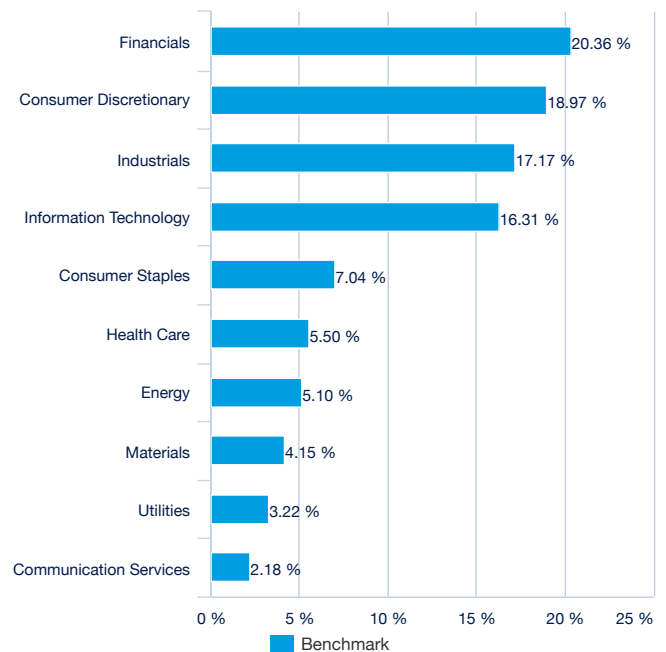
