Objective and Investment Policy

This Sub-Fund is passively managed. The objective of this Sub-Fund is to track the performance of S&P MidCap 400 Index (the "Index"), and to minimize the tracking error between the net asset value of the Sub-Fund and the performance of the Index. The anticipated level of the tracking error, under normal market conditions, is indicated in the prospectus of the Sub-Fund. The Index is a Net Total Return Index, dividends net of tax paid by the index constituents are included in the Index return. The Index is an equity index which is distinct from the large-cap S&P 500 and that provides investors with a benchmark for mid-sized U.S. companies. The Index is composed of 400 constituent companies and is designed to measure the performance of mid-cap segment of the U.S market, reflecting the risk and return characteristics of this market segment. The Index is weighted by float-adjusted market capitalization. More information about the composition of the index and its operating rules are available in the prospectus and at: spdj.com. The Index value is available via Bloomberg (SP400NTR). The Sub-Fund will apply an Indirect Replication methodology to get exposition to the Index. The Sub-Fund will invest into a total return swap (financial derivative instrument) delivering the performance of the Index against the performance of the assets held. Derivatives are integral to the Sub-Fund's investment strategies.

Under the ESMA rules or the FCA rules, funds distributed in the EU or the UK are not allowed to report performance returns if the fund is less than 12 months old.

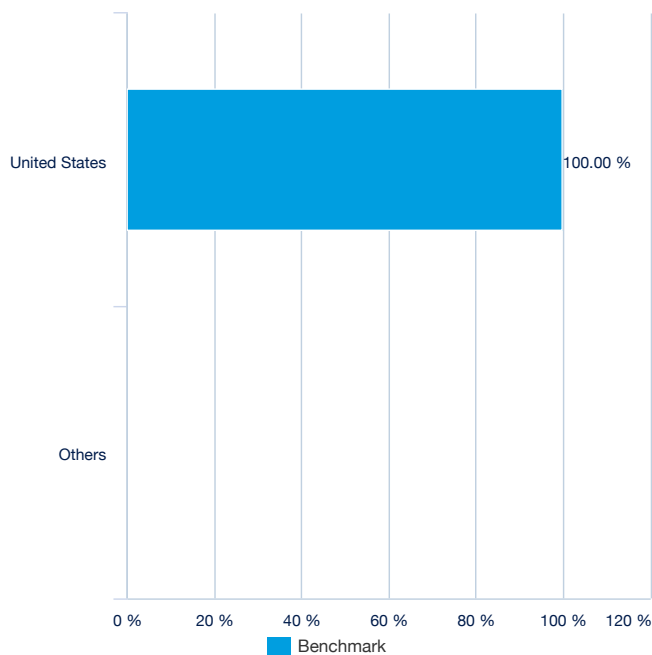

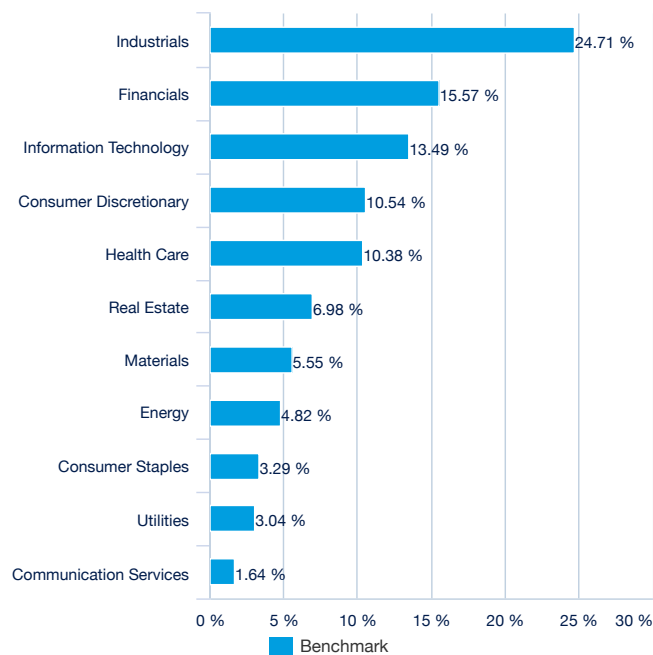
